

Certification for One and the Same Person

➤ **For applicants who have changed names due to marriage:**

1. Personal appearance of applicant
2. Two (2) Duly Accomplished General Affidavit forms stating the reason behind the need of change of name. Please also narrate the details of marriage and the purpose of the certification.
3. Two (2) copies each of the applicant's previous passport (bearing single name), current passport (bearing the married name) and residence visa
4. Two (2) passport copies of the applicant's spouse
5. Certified Original Copy of Marriage Certificate or Report of Marriage from the Philippine Statistics Authority (PSA) duly authenticated by the Department of Foreign Affairs in Manila
6. Photocopy of the said document.

❖ **After the submission of the Affidavit, the Embassy will issue a Certification.**

➤ **For applicants who have changed names due to an annulment:**

1. Personal appearance of applicant
2. Two (2) Duly Accomplished General Affidavit forms stating the reason behind the need of change of name. Please also narrate the details of annulment and the purpose of the certification.
3. Two (2) copies each of the applicant's previous passport (bearing married name), current passport (bearing reverted to single name) and residence visa
4. Certified Original Copy of Marriage Certificate or Report of Marriage from the Philippine Statistics Authority (PSA) with annotation duly authenticated by the Department of Foreign Affairs in Manila
5. Photocopy of the said document.

❖ **After the submission of the Affidavit, the Embassy will issue a Certification.**

➤ **For applicants who changed names due to legitimation:**

1. Personal appearance of applicant
2. Two (2) Duly Accomplished General Affidavit forms stating the reason behind the need of change of name. Please also narrate the details of legitimation and the purpose of the certification.
3. Two (2) copies each of the applicant's previous passport (bearing the old name), current passport (bearing the changed name) and residence visa
4. Certified Original Copy of Copy of Birth Certificate or Report of Birth from the Philippine Statistics Authority (PSA) with annotation duly authenticated by the Department of Foreign Affairs in Manila
5. Photocopy of the said document.

❖ **After the submission of the Affidavit, the Embassy will issue a Certification.**

➤ **For applicants whose passport data page bears discrepancy:**

1. Personal appearance of applicant
2. Two (2) Duly Accomplished General Affidavit forms stating the reason behind the discrepancy and the purpose of the certification.
3. Two (2) copies each of the applicant's previous passport, current passport (with discrepancy) and residence visa
4. Certified Original Copy of Birth Certificate or Report of Birth from the Philippine Statistics Authority (PSA) duly authenticated by the Department of Foreign Affairs in Manila
5. Photocopy of the said document.
