

## **No Objection Certificate for UAE Residence Visa Applications**

*For dependents whose sponsor is outside the UAE.*

### **Core Requirements:**

1. Personal appearance of dependent
2. Two (2) accomplished General Affidavit stating the reason and purpose of the certification
3. Two (2) valid passport copies of sponsor and dependent
4. Two (2) copies of residence visas of sponsor and dependent
5. Signed letter from the sponsor stating the authorization for processing the said documents, reason and purpose of the certification.

### **Case-additional requirements:**

- If the dependent is spouse, present original and submit two (2) copies Marriage Certificate
  - If the dependent is a child, present original and submit two (2) copies of dependent's Birth Certificate
  - If the dependent is a parent, present original and submit two (2) copies of sponsors Birth Certificate
  - If the sponsor is a seaman, a copy of his seaman's book (SIRB) should be submitted.
  - If the sponsor is working offshore, letter from the company stating his whereabouts duly stamped and signed.
  - Other supporting documents may be asked upon application.
- ❖ **After the submission of the Affidavit, the Embassy will issue a No Objection Certificate.**
