

## **No Objection Certificate (NOC) for Issuance of Foreign Passport to Minor**

*For Issuance of Foreign Passport to minor whose either mother or father is a Filipino national*

### **Core Requirements:**

1. Personal appearance of Filipino parent
2. Two (2) accomplished General Affidavit
3. Two (2) passport copies of both parents
4. Two (2) copies of residence visas of both parents
5. Present original and two (2) copies of Report of Marriage of parents issued by the Philippine Embassy
6. Present original and two (2) copies of the Report of Birth of the child issued by the Philippine Embassy
7. Present original and two (2) copies of the Birth Certificate issued by the UAE Ministry of Health and attested by the UAE Ministry of Foreign Affairs (MOFA)

### **Case-additional requirements:**

- Other supporting documents may be asked upon application.
- **After the submission of the Affidavit, the Embassy will issue a No Objection Certificate.**
